3. The School Management shall be having full responsibility if any court case arise in this regard. The details furnished if any by the management is found to be false or incorrect at any stage. This No Objection Certificate is liable to be cancelled.






- account regarding expenditure involving payment of salaries, rent, electricity, water, stationery and other miscellaneous expenditure
- It is open for the governing body to take a decision to collect fees from students either monthly or quarterly or half yearly.
 - The Managements of the Schools shall display the fees and other charges being collected in the Schools in the notice board of the school before the commencement of the admission, so that every parent can know the same and take decision for the admission of their wards in the schools.
 - The Educational agency shall submit the annual administration report in the prescribed preformed to the competent authority for every financial year by the 30th September at the latest. Such report shall be supported by the audited statement of accounts of the school duly audited by Chartered Accountant. Separate accounts shall be maintained for each school.
 - The School managements shall upload their schools information in the web site of the department including their fees details and other required information useful to the parents.
 - The Management should follow the provisions of A.P. Education Act I of 1982/G O.Ms.No.1 Edn. Dated 01.01 1994 and Telugu Language be imparted as I or II Language compulsorily.


